What you need to bring:

- Valid photo identification.
- Original Social Security Cards for all household members. (Mandatory for all clients this year, even returning clients!)
- A copy of last year's tax return if available.
- Health Insurance Forms: **If you purchased insurance through Healthcare.gov you must bring Form 1095-A.** Forms 1095-B/C for other types of insurance are optional this year, but you must know your coverage dates for all household members.
- Income documents such as Forms W-2, W-2G, & 1099 from all employers and other sources (social security, unemployment, pension, etc.).
- Interest and dividend statements from banks (Forms 1099).
- Bank Routing Numbers and Account Numbers for Direct Deposit of refund.
- For students with post-secondary tuition expenses or grant income bring Form 1098-T.
- Total paid for day care provider and the day care provider's tax identifying number.
- Identity Theft prevention pin, if assigned by the IRS.
- Both spouses must be present to sign the required forms for Married Filing Jointly returns.
